| Sibling | Siblings (brothers or sisters) are considered to be those children who live at the same address and either: <br> i. have one or both natural parents in common; <br> or ii. are related by a parent's marriage; <br> or iii. are adopted or fostered by a common parent. <br> Unrelated children living at the same address, whose parents are living as partners, are also considered to be siblings. <br> Children not adopted or fostered or related by a parent's marriage or with one natural parent in common, who are brought together as a family by a same sex civil partnership and who are living at the same address, are also considered to be siblings. |

| Children of Staff | Admission authorities may give priority in their oversubscription criteria to children of staff in either or both of the following circumstances: <br> a) Where the member of staff has been employed at the school for two or more years at the time at which the application for admission to the school is made. <br> b) The member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage. |
| Distance | Distances are calculated on the basis of a straight-line measurement between the applicant's home address and the main school gates. The Local Authority uses a computerised system, which measures all distances in metres. Ordnance Survey supply the co-ordinates that are used to plot an applicant's home address and the address of the school. |
| Shared Responsibility | Where parents have shared responsibility for a child, and the child lives with both parents for part of the week, then the main residence will be determined as the address where the child lives the majority of the week. Parents may be requested to supply documentary evidence to support the address used. |
| Final Qualifier | In a very small number of cases it may not be possible to decide between the applications of those pupils who are the final qualifiers for a place, when applying the published admission criteria. <br> For example, this may occur when children in the same year group live at the same address, or if the distance between the home and school is exactly the same, for example, blocks of flats. If there is no other way of separating the application according to the admissions criteria and to admit both or all of the children would cause the Published Admission Number for the child's year group |
